#### **Guest Speaker**

Community Services Administrator, Lindsay Turman
 Topic: Code enforcement and community services

Community Services Administrator, Lindsay Turman provided an informative presentation on the City of Richardson Community Services department. Lindsay Turman has been with the city for 16 years and oversees and manages a staff of 15 in the Community Services division. Community services is responsible for code enforcement and community programs.

**Code Enforcement** – covers residential, commercial, multi-family, and rental code enforcement programs. The goal of code enforcement is to work with people "to maintain the city's integrity by making certain its residential neighborhoods, apartment complexes, and commercial areas are kept in a safe and healthy manner through fair and reasonable enforcement of codes and ordinances".

Residential Code Enforcement - Proactively drive all residential streets and alleys on a monthly basis:

- Follow standard operating procedures
- Failure to comply can result in citations, abatement, or a case at the Building and Standards Commission
- Number one code enforcement issue is trees, followed by other areas such as, high grass, open storage, trash and debris, junk vehicles, and maintaining minimum property standards

# **Respond to citizen complaints**

- You can report code violations online at the COR website
- The **My Richardson App** is also available for residents and allows you to easily report issues and receive updates. The app is available for Apple or Android smartphones
- All received complaints are investigated and responded to within 24 hours

**Commercial & Multifamily Code Enforcement -** City-wide regularly scheduled inspections for commercial properties and apartment complexes for code enforcement areas such as zoning, parking, health, and property standards.

**Rental Registration** – The purpose of the rental registration program is to protect the vitality and integrity of the City by ensuring its rental housing is properly maintained.

**Short-Term Rental (STR)** – means a residential property that is rented for a fee for a period not longer than 30 consecutive days.

- Requires annual registration fee of \$75
- There are less than 100 STRs in the City of Richardson
- The property must have a local individual the city and police can contact if needed
- The City Manager has the right to revoke a registration
- Primary issues reported for STR are noise or trash

**Community Programs** – "strives to create successful and sustainable Richardson neighborhoods". The division covers all neighborhood-centric programming for the City of Richardson including the Home Improvement Incentive Program, Volunteer Assistance Program, Sign Topper Program, Wall Washing / Painting Program, Neighborhood Leadership Workshops, and other community-wide programming. Some of these programs were discussed in the presentation.

**Home Improvement Incentive program** – designed to provide an economic incentive to homeowners.

- All homeowners in single-family zoned areas are eligible to participate
- To qualify, an improvement project must involve reconstruction or remodeling cost at least \$20,000 and be completed within 24 months of project approval
- Must apply for the program prior to work beginning

**Support for our Neighborhoods** – City of Richardson supports our neighborhoods in multiple areas.

- **Neighborhood Leadership Workshops** "designed to provide leadership training for neighborhood and other community associations in Richardson".
- Monthly City Council / Presidents Meetings promotes a two-way discussion concerning important neighborhood issues.
- **Sign Topper Program** helps neighborhoods be recognized for their unique character and increase visibility.
- **Newsletters & Publications** articles designed to assist neighborhood associations.
- **Volunteer Assistance Program** Community services partners with volunteer groups to help residents maintain their property. The purpose is to help home owners who cannot properly maintain their property due to age, finance, or disability.
- **Graffiti Abatement Program** is committed to eliminate graffiti on public and private property in a timely manner at no cost to residents.

# **Berkner Park Playground Update**

Berkner Park received upgraded amenities, including new playground equipment. Voters approved the
renovations as part of the 2021 bond program, and Berkner Park is the fourth park in Richardson to receive
upgrades. In addition to the new playground equipment, the park received benches, shade structures and
sidewalk approaches. Many residents are enjoying the new playground.

# **Street Sign Toppers**

### Overview:

- First Ordered in 2012
  - 40 Locations 80 Total Sign Toppers
  - Two Single Sided Toppers Per Street Sign
  - \$53 Each | \$106 Per Street Sign
  - Approximately \$4,240 for 80 Toppers
- Current 2023 Sign Topper Prices
  - \$113 Each | \$226 Per Street Sign
  - \$9,040 Replacement Cost Estimate

## **Replacement Approach:**

- Establish a Replacement Criteria
- Evaluate All 80 Sign Toppers
- Create a Replacement Budget
- Treasury Balance KEY Factor
- Determine Replacement Locations
- Two Installation Options
- All At Once or Piecemeal

- Now Installed Oakridge & Camelot
- One Double Sided Topper Per Street Sign
- \$113 Each Single Sided Two Color
- \$140 Each Double Sided Two Color

- Saves Thousands of HOA/NA Dollar
- Downside Installation Hardware Shows

### **Neighborhood Concerns**

- Neighborhood concerns discussed:
  - Sears Building Retail Leasing City is closely monitoring but there are no new developments.
  - Bates & Butler Berm Condition City continues to monitor the area and work with the property owner.
  - Rental Property & Short Term Rentals The city required an annual registration beginning January 1, 2023 with an annual registration fee of \$75.
  - Poor Street lightning in Berkner Park City is not responsible for the lights around the park or neighborhood streets. The lights are owned and handled by Oncor. The City of Richardson has no direct control over street lights in the park or Berkner Park residential streets. Residents must work directly with Oncor.
